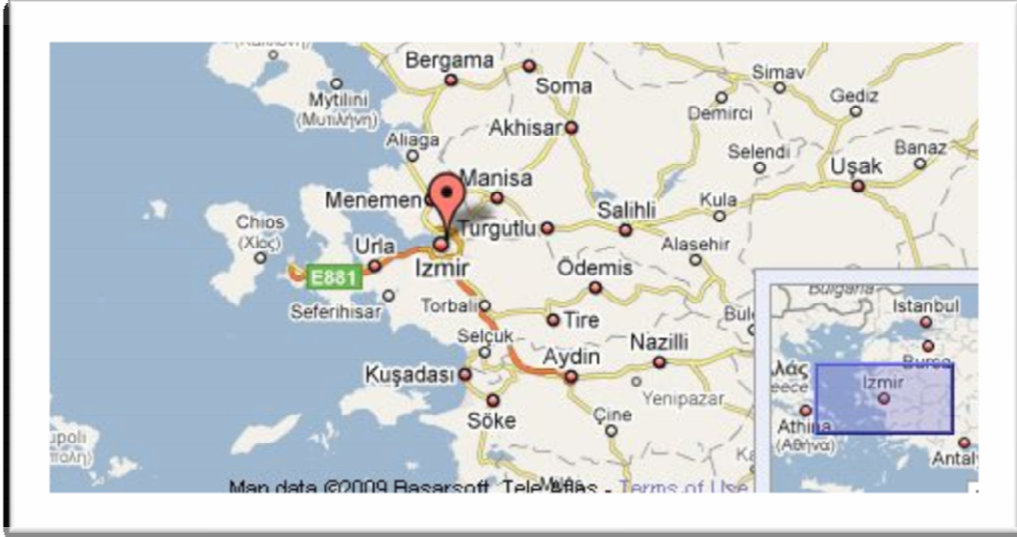

Armenia: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain one-month multiple entry visas at the Turkish border gates.

Austria: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three month-multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Azerbaijan: Ordinary passport holders are exempt from visa requirement for their travels to Turkey up to 30 days. Official passport holders are exempt from visa requirement for their travels up to 90 days.

Belarus: Ordinary passport holders are required to have visa to enter Turkey. They can obtain two-month multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Belgium: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three-month multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Bosnia-Herzegovina: Ordinary and official passport holders are exempt from visa for their travels up to 60 days.

Bulgaria: Diplomatic and service passport holders are exempt from visa for their travels up to 30 days. Ordinary passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date.

Croatia: Ordinary and official passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date.

Czech Republic: Official and ordinary passport holders are exempt from visa for their travels up to 90 days.

Cyprus: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain one-month single entry visas at the Turkish border gates.

Denmark: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Estonia: Only diplomatic passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date. Ordinary passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date.

Finland: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

France: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Georgia: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Germany: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Greece: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Hungary: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one-month multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 30 days.

Iceland: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Ireland: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain three-month multiple entry visas at the Turkish border gates.

Israel: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Italy: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Latvia: Ordinary passport holders are exempt from visa requirement for their travels up to 30 (thirty) days. Diplomatic and service passport holders are exempt from visa requirement for their travels up to 90 (ninety) days.

Liechtenstein: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Lithuania: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one-month multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Luxemburg: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

FYROM: Ordinary and official passport holders are exempted from visa for their travels up to 60 days.

Moldova: Official passport holders are exempt from visa for their travels up to 30 days.

Ordinary passport holders are required to have visa to enter Turkey. They can obtain one-month multiple entry visas at the Turkish border gates and may benefit from this facilitation for up to 90 days of stay within 6-months period.

Monaco: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Montenegro: Official and Ordinary passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date.

Netherlands: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three month-multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Romania: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one-month single entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days within 6 months starting from the first entry date.

Russian Federation: Ordinary passport holders are required to have visa to enter Turkey. They can obtain two month-multiple entry visas at the Turkish border gates. Only diplomatic passport holders are exempt from visa for their travels up to 90 days.

Serbia: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one month-multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Slovakia: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one month-multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Slovenia: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three month-multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

United Kingdom: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain three month-multiple entry visas at the Turkish border Gates. "British National Overseas (BNO)" or "British Protected Persons (BPP)" passport holders are NOT issued visas on the Turkish border Gates They must apply to the Turkish representations abroad in order to get visa (Hong Kong citizens holding BNO passport can obtain visa on the border gates).
