

# **COVID- 19 PROTOCOL**

## **56th EKF European Senior Karate Championships - Porec, Croatia - May 19 - 23, 2021**

### **1. GENERAL CONSIDERATION**

The COVID-19 pandemic has forced significant changes in the whole world and, of course, also in the world of sports. This protocol is made for protection against infection with the new corona virus SARS-CoV-2 during the 56th European Senior Karate Championships which is held in Porec from 19<sup>th</sup> to 23<sup>rd</sup> of May 2021. The protocol envisages all preventive activities in order to prevent possible infection of participants with the new corona virus during the competition. The basic principle of protection during the organization of 56th European Senior Karate Championships is: to protect and be protected by respecting the provisions and recommendations of this protocol. This means that all participants have a mutual responsibility and obligation to protect each other in such a way.

Effective protection of the health and safety of athletes is our priority. The protocol will be available to all participants of the 56th European Senior Karate Championships on the official website of the competition ([www.karateporec2021.com](http://www.karateporec2021.com)) so that all participants can get acquainted with its provisions in a timely manner.

The protocol was made in collaboration with national and local public health authorities and is subject to changes in accordance with the epidemiological situation in the Republic of Croatia and applicable legislation.

All information regarding the conditions of entry into the Republic of Croatia considering temporary bans, i.e. restrictions in place to prevent the spread of COVID-19 can be found here: <https://mup.gov.hr/uzg-covid/english/286212>.

### **2. INDIVIDUAL RESPONSIBILITY**

- Participants should aim to keep at least 2 meters distance from other people, particularly those who don't wear a certified mask, and especially if they feel unwell and have a cough or sneeze or may have a fever;

- Frequent hand washing by participants using soap and hot water or alcohol-based (at least 65–70%) hand rub for 20 seconds;

- People should practice cough etiquette (maintain distance of at least 2 meters, cover mouth and nose while coughing and sneezing with disposable tissues or clothing, and wash their hands);

- To avoid shaking hands or hugging;

- Avoid steam rooms or sauna;
- Avoid touching their own mouth, nose or eyes.

Anyone who feels unwell (i.e. fever, cough) should stay at a hotel, inform team manager and keep away from competition venue until symptoms resolve. Team manager has obligation to inform LOC of such situation and further action will be taken.

**Stay away from the event when ill!**

### **3. PARTICIPANTS' HEALTH SCREENING PROTOCOL (ATHLETES, COACHES, OFFICIALS, REFEREES, LOC STAFF AND MEDIA)**

All participants in the European senior karate championships event must monitor their health status continuously (including taking their temperature and monitoring for any symptoms) from 14 days before their arrival and also during the event.

All participants must undergo a RT-PCR nasopharyngeal swab test (RT-PCR test) at least 48 hrs prior to onsite registration (**only tests made from 16<sup>th</sup> of May will be accepted**).

**Without a valid RT-PCR test, no accreditation will be given. No other tests will be accepted.**

At the onsite registration, all participants shall submit the following documents:

- I) **Original Laboratory Accredited PCR Test Results in English**
- II) **Completed WKF Health Questionnaire (Annex I)**
- III) **Waiver of Liability Form**
  - a. Delegation/Team Representative (Annex II)
    - i. Delegation List
  - b. Individual Form (Annex III)
  - c. Parental consent (Annex IV)

The Representative of the Delegation/Team will be responsible for ensuring the validity of all signatures.

After the onsite registration process, **all participants must undergo an Antigen Test**, except for Athletes, Coaches, Physical Therapist and Doctors. They shall undergo Antigen Testing each day of competition during the staggered time slot corresponding to their category which will be organized by the WKF Organizing Committee.

When performing the Antigen Test, all participants will hand over their accreditation, then they will perform the test and go to the waiting room. The Covid Manager (doctor) will return your accreditation upon a negative test.

Any positive test or symptom of COVID-19 (fever, dry cough, sore throat, taste and smell disorder, digestive symptoms, fatigue and exhaustion) will be instructed to isolate immediately, and local authorities will be informed by Local Covid Manager. Local authorities will proceed according to Local Health Regulations. The LOC will provide as much information in its possession as required by the Local Authorities.

Temperature checks will be performed daily at the entrance of the venue. Access to the venue **will be denied** to those who have a temperature of **37,2 degrees or above**.

**Any participant that does not comply with the established WKF Covid Protocol will not receive their accreditation or access to the event.**

#### **4. RETURNING HOME - PCR / RAT LABORATORY EVENT TESTING**

The LOC will arrange and guarantee the availability of an accredited laboratory for the participants who need a RT-PCR or Rapid Antigen Test to return home.

The results in English will be provided to all participants before the last day of their departure. The sample collection or laboratory will not be in the same venue as the competition.

**Price of RT-PCR test: 110€.**

**Laboratory: Public Health Istria.**

**Days: every day during competition.**

**Schedule: will be determined according to the needs of delegations (planned time of departure).**

**Location: Hotel Diamant and Parentium.**

#### **5. PARTICIPANTS' PREVENTION MEASURES**

**(Certified Masks, Disinfection, Social Distance and Other General Methods)**

##### **Certified Masks**

The use of Certified Masks of FFP2 type or equivalents (N95 (United States), KN95 (China), P2 (Australia/New Zealand), Korea 1st class (Korea), DS2 (Japan)) **without valves** within the specifications for use **is always mandatory** in the venue, with the exceptions for athletes that are detailed herein. Once an athlete enters the venue grounds the athletes must always wear Certified Masks except while warming up, training, and competing in the designated areas/ tatamis, respectively. This also means the Certified Mask shall be worn in transit between the Warmup and Competition Areas. The LOC is responsible for providing the EKF Official Certified Masks **only** to its referees and staff along with a contingency amount for medical needs.

Disinfecting alcohol-based hand sanitizers and tissues should be accessible in all common areas, and especially in the warm-up, medical treatment areas, and at the entrance and exit doors of the all-designated areas (Registration, Weigh-In, Antigen Test, Warm up, Competition area).

Hand and leg/foot protections shall be disinfected, with a product with viricidal effect that is nontoxic for humans, immediately before each bout, with enough time to allow them to dry before the start of the bout.

Competition, Warm Up Area's, Antigen Test waiting room will be disinfected with a product with viricidal effect that is nontoxic for humans at the end of each category.

Physical Distance (at least 2 meters) separation of all participants, expect for athletes in bouts. The social distancing rules that are requested by the public health authorities of the specific country where the event is taking place takes precedents.

There will be no physical signs of affection or recognition between athletes or coach before, during or after competition like hugs, handshakes, or kisses.

The flow of participants will be one-way only, with the relevant signage on the floor, indicating the right direction with separate entrances and exits to all rooms.

Sharing of equipment is prohibited, especially water bottles, towels, bags, and cups.

**Any participant that does not comply with the established prevention measures, their accreditation will be removed and will be asked to leave the venue.**

## **6. MEDICAL PROVISIONS AND RECOMMENDATIONS**

The most common symptoms of COVID-19 disease are: fever, dry cough, sore throat, taste and smell disorder, digestive symptoms, fatigue and exhaustion, and shortness of breath. Therefore, all participants, whether competitors or staff, international or local, must comply with the following provisions:

Athletes and members of delegations as well as accompanying staff and all accredited persons may not participate in the competition and training or enter the competition venue in case of any symptoms of SARS-CoV-2 infection.

In a case of COVID-19 suspicion further actions will be taken by local authorities according to Local Health Regulations.

**All costs of possible medical treatment, as well as prolonged hotel stay, will not be covered by LOC!**

It is recommended that all participants of the 56th European Senior Karate Championships have health insurance which, in addition to all other adverse events, covers treatment with COVID-19.

Alcohol-based hand sanitizers will be accessible in all common areas and especially in the warm-up and medical treatment areas.

We recommend that towels are for single use only and kept in the athlete's bag when not in use.

## **7. PARTICIPANTS' CONDUCT**

The following measures will be in place:

- Daily health screening of participants when accessing the competition venue:
  - a) body temperature check of all accredited persons (except athletes, coaches, physical therapists, doctors) with contactless thermometers,
- Daily health screening of participants (athletes, coaches, physical therapists, doctors) before accessing the competition venue:
  - a) body temperature check with contactless thermometers AND
  - b) validated antigen test

The organizing staff and the officiating Referees will have to arrive at the venue in advance in order to pass the necessary standard security check, as well as a health screening, before the first competition category starts.

The athletes will reach the venue in separate groups, according to the competition categories that will take place in the different timings scheduled by the LOC.

Physical (at least 2 meters) separation of athletes, officials and support staff upon arrival to the venue is mandatory, as well as wearing certified mask.

**Anyone due to participate in the event who is feeling ill or has common symptoms of COVID-19 disease (fever, dry cough, sore throat, taste and smell disorder, digestive symptoms, fatigue and exhaustion, and shortness of breath) should not come to the competition venue and must notify the Team Director immediately who is obligated to contact Tournament Chief Doctor (TChD, from the LOC) about such participant.**

Athletes should wear certified masks when in competition venue and maintain frequent hand washing or sanitizing, even if wearing rubber/disposable gloves during any non-competition activity.

**(Please be reminded that even while wearing rubber/disposable gloves and certified masks you still need to disinfect and keep social distance.)**

Sharing of equipment is strictly prohibited, in particular regarding water bottles and cups.

## **8. VENUE FACILITIES**

All working spaces and provided facilities are organized in a way that social distancing is respected. At the entrance of the venue, warm-up and competition area, alcohol-based hand sanitizers will be available.

Warm-up and competition area will be disinfected several times per day.

Closed bins for safe disposal of hygienic materials (e.g. tissues, towels, sanitary products) in all areas will be provided.

## **9. ACCREDITATION**

The number of people inside an accredited area will be restricted. Those with access will be limited to the absolute minimum and social distancing in relation to available venue area space.

Only one coach per competition category and one medical doctor plus one physiotherapist per NF will be accredited to the event. The maximum quota of coaches allocated to the delegations as per the WKF Organizing Rules shall always be respected.

The re-validation of the accreditation card will be on a daily basis following the health screening process.

**Any participant that do not comply with the established prevention measures, their accreditation will be removed and will be asked to leave the venue.**

## **10. SOCIAL ACTIVITIES**

Farewell parties and opening/closing ceremonies are not planned so as to minimize the opportunities of mass gathering in small spaces.

## **11. STAFFING**

The social gathering of the LOC team and its volunteers will be kept to an absolute minimum. All training sessions should take place on site while respecting social distancing. The number of volunteers will be reviewed and kept down to the absolute necessary. The working conditions are following the recommendations from the Local Public Health Authorities.

## **12. SPECTATORS**

Spectators are not allowed in the competition areas. Changes are possible according to the recommendations from the local and national Health Authorities at the time of the competition.

## **13. MEDIA**

Number of accredited media representatives will be limited taking into account social distancing and the available space. The media center will be prepared with at least 2 m between each seat/working space and each row of seats. The wearing of certified masks is mandatory. During Medal presentation ceremonies, a distance of 2 m must be kept between the photographers. The media representatives must go through the same health screening process as the rest of the accredited groups.

## **14. TRANSFERS TO THE VENUE**

The LOC will provide all those accredited persons with transport from the official hotels to the competition venue, according to the specific transportation information for each event as detailed in the event rules.

The total occupancy of the buses will be limited, and a safety distance will be maintained occupying only one seat out of two of each vehicle. The use of certified masks is mandatory inside the buses for all.

There will be dedicated buses for the teams / delegations and different ones for the Referees and staff.

There will be a staggered bus Schedule, according to each competition category.

All safety and sanitary measures must be followed. The transport of athletes and teams will follow strict schedules, in order to avoid great crowds in the warm-up and competition areas. The staggered arrival to the venue will also allow the health screening of all those involved in competition.

## **15. WEIGH-IN ZONE IN/OUT**

The officials and volunteers involved in the process must wear certified masks. Athletes shall also wear certified masks during the weigh-in process. Social distancing inside the weigh-in area shall be respected. LOC will establish check-in times for weigh-in in specific time slots according to the order of competition and the number of entries. The number of athletes accessing the weigh-in area will not exceed 10 persons and will follow strict order by category and country in alphabetical order. All the necessary checks will be carried out visually, whenever possible. The officials may need to do a physical check to some athletes. In this case, sanitary wipes or hand sanitizers will be available to athletes and officials for wiping down or hand sanitizing after officials checked the athlete. After each weigh-in group has finalized, the elements used in the weigh-in area will be sanitized. Alcohol-based hand sanitizers and tissues should be available at the entrance and exit doors of the weigh-in area.

## **16. ATHLETE CLASSIFICATION (PARA-KARATE)**

### **a. GENERAL**

All applicable Prevention Measures (Section 5) must be always respected.

Timing of the appointments will need to be flexible enough to offer the opportunity to air out the classification room which must have windows, and to clean and disinfect the equipment used in each case.

General requirements for classification will be shared in advance between the Para-Karate Commission and the LOC and will contain the main provisions around hand sanitizer and disinfectant wipes to clean down the examination equipment.

Number of people apart from classifiers, athletes and NF representatives will be minimized as much as possible, so that there is one accompanying person only. No observers allowed in this period.

The Chief Classifier will make the final decisions on the required provisions to ensure safety of the environment.



Disposable Certified Masks and rubber/disposable gloves should be available to classifiers for each athlete session.

Athletes must wear Certified Masks and to perform frequent hand washing or sanitizing during the classification process.

National Federations and athletes must adhere to the classification schedule according to the World Karate Federation Classification Rules.

#### **b. PHYSICAL IMPAIRMENTS**

One-meter-wide paper roll, to be disposed of after each athlete using the test bench or chair, should be provided.

Athletes shall be allowed to use their own wheelchairs during the classification process. Functional testing will need to be done, and a space at least 8x8 meters without obstacles (pillars, columns, stairs, etc.) is required.

Body contact by the classifiers will be kept to the minimum.

### **17. COMPETITION**

#### **a. WARM-UP AREA**

All applicable Prevention Measures (Section 5) must be always respected.

The warm-up area shall be of at least 9m<sup>2</sup> per athlete (and coach) and visible marked. If possible, the tatami will be identified by flipping pieces for alternate blue/red color of respectively 9m<sup>2</sup>, to assist the athletes to stay within their own area.

The access to the warm-up area will be restricted to one coach for each competitor. Except during the medal rounds, where it will be limited to 1 coach and 1 practice partner (must be a registered athlete) for each competitor. Team physios and doctors will not be able to access the warm-up area and a separate room will be made available for those athletes needing treatment.

No other athlete or coach, other than those involved in the competition area in the ongoing category will be allowed to access the warm-up area.

After each competition category / group leaves the warm-up area, it will be sanitized.

As mentioned in previously, only athletes may take of their Certified Masks while in the warmup area, immediately prior and must put it back on immediately afterwards.

## **b. CHANGING ROOMS & TOILETS**

All applicable Prevention Measures (Section 5) must be always respected.

The use of changing rooms and toilets will have limited occupancy only and will be sanitized after each use.

## **c. COMPETITION AREA**

All applicable Prevention Measures (Section 5) must be always respected.

The flow of athletes and officials will be one-way only, with the relevant signage on the floor, indicating the right direction.

The competition equipment of each athlete, mitts and shin pad & foot protector, will be sanitized by a staff member before each bout, at the seat in the waiting area of each tatami.

After each category, the tatami area, as well as the scorekeepers' table will be sanitized. There must be an appropriate number of disinfecting units and/or staff to maintain the rhythm of the competition.

Alcohol-based hand sanitizers and tissues should be available at the entrance and exit of the FoP, as well as on the officials' and scorekeepers' tables.

A dedicated cleaning team shall be available on the competition area with the adequate cleaning and sanitizing materials for their use, whenever required. There must be an appropriate number of disinfecting units/or people in order to maintain the rhythm of the competition.

## **18. REFEREES**

Health screening will be performed as described in SECTION 3.

All Covid Prevention Methods (SECTION 5) must be always respected.

Referees will use an electronic whistle, for which a specific procedure will be detailed to the Referees by the WKF RC Chair.

Referees will be provided disposable gloves prior to the beginning of the kumite competitions since the red and blue Flags will be shared.

## **19. MEDAL CEREMONIES**

Medals will be presented on a plate/stand/post by the EKF/WKF Representative or other delegate and placed near to the podium. The athlete must put the medal around his/her neck by himself/herself.

Certified masks of FFP2 type or equivalents (N95 (United States), KN95 (China), P2 (Australia/New Zealand), Korea 1st class (Korea), DS2 (Japan)) without valve will be of compulsory use for the medal presenters and the athletes at the medals' ceremonies. The medal presenters will receive one certified mask beforehand.
